#### ALL CONTRACTORS MUST COMPLETE WITH THE CONDITIONS OUTLINED BELOW:

All parties entering Gippsland Water confined space/s must be familiar and carry out works in accordance with the Occupational Health & Safety Regulations 2017 (Part 3.4), AS2865-2009 Confined Spaces, WorkSafe Compliance Code 'Confined Spaces', Gippsland Water Confined Space Entry and Associated Works' Procedure and the most recent version of the Sewerage Code of Australia (MRWA Edition) and Gippsland Water's Supplement to the code.

All contractors working on Gippsland Water assets must have completed the Gippsland Water Contractor Environmental and Public Health & Corporate Occupational Health & Safety Online Induction via the link: https://online.gippswater.com.au/induction/?a=cHBzd2F0ZXluY29tLmF1fjV2bUm9ilE1IYWxsR4hb S5oYWxsQGdp Upon request by Gippsland Water, evidence of a current online inductions must be shown.

If Gippsland Water assets are located within private property, the contractor must notify property owner/s three (3) days in advance and gain permission to access their property prior to the commencement of works. If no permission is given, no access should be made.

All safety equipment and machinery must be appropriately maintained, and a service history always kept with the equipment.

During inspection of, and works on Gippsland Water sewers and/or maintenance structures the pipelayer must:

• Check prior to entering any confined space that entry is safe via completion of a safety checklist (e.g. Job Safe Environmental Analysis, Confined Space Entry Permit).

• Wear and use correct safety gear (Personal Protective Equipment) and work in a responsible safe manner.

• Minimise disruption to affected customers and the general public.

• Reinstate all disturbed surfaces and return Gippsland Water assets to an operational state, leaving site clean and safe.

Have obtained all appropriate permits from the relevant authorities for the works.
